Introduction

This form must be completed in respect of any transfer of Water Shares in Waimea Irrigators Limited (**WIL**). Any transfer must be approved by WIL and then registered in WIL's share register in order for the transfer to be effective.

Until WIL receives this information, it will not approve the transfer of the Water Shares and will not register the transfer in its share register. This means that the transferee will not have legal title to the Water Shares and the transferor will continue to own these shares and responsible for all obligations associated with them.

By acquiring Water Shares, the transferee will assume all of the obligations associated with those Water Shares, including responsibility for payment of all amounts that have not yet been paid to WIL in respect of those Water Shares, such as the outstanding purchase price for the shares, the construction operating charge, and all other Water Charges payable to WIL from time to time in accordance with its Constitution and its Shareholder Water Augmentation Agreement (SWAA).

WIL will incur costs as part of any transfer of Water Shares. The transferee will be responsible for meeting WIL's reasonable costs associated with the transfer (including legal costs).

 request by WIL; and
- acknowledges that WIL may from time to time, amend the terms of the SWAA in accordance with the SWAA, and that the transferee will be bound by any such amendment on receiving written notice of the change.
