**2. No trusts**

There are no trusts entered on this register.

**3. Restrictions and limitations on share transfers**

The following restrictions and limitations apply to the transfer of shares issued by the Company:

(a) **Water Shares**

- (i) restrictions or limitations under the constitution:

**"Transfer between Properties**

6.1 Subject to clause 6.12, a holder of Water Shares may transfer its Water Shares to another property owned or leased by the same holder of Water Shares.

**Transfer to New Entity- In Scheme Area**

6.2 Subject to clause 6.12, a holder of Water Shares may transfer its Water Shares to a person or entity that owns or leases a property in the Scheme Area who holds a Ground Water Permit or Surface Water Permit.

**Transfer to New Entity- Out of Scheme Area**

6.3 Subject to clause 6.12, a holder of Water Shares may transfer its Water Shares to a person or entity that owns or leases a property outside of the Scheme Area who holds a Ground Water Permit and/or Surface Water Permit to take water within the Scheme Area and can be supplied water from that Ground Water Permit and/or Surface Water Permit.

### **Transfer to New Entity- Shareholder or Member of Existing Scheme**

6.4 Subject to clause 6.12, a holder of Water Shares may transfer its Water Shares to a shareholder or member of an irrigation scheme that holds a Ground Water Permit and/or Surface Water Permit to take water within the Scheme Area.

### **Transfer to New Entity- No Permit**

6.5 Subject to clause 6.12, a holder of Water Shares may transfer its Water Shares to a person or entity that does not hold a Ground Water Permit and/or Surface Water Permit but owns or leases land within the Scheme Area and wishes to apply for a Ground Water Permit and/or Surface Water Permit once it holds a Shareholder Water Augmentation Agreement which the Company has executed.

### **Transfer to New Entity- No Land/ No Permit**

6.6 Subject to clause 6.12, a holder of Water Shares may transfer its Water Shares to a person or entity that does not hold a Ground Water Permit or a Surface Water Permit who does not own or lease land within the Scheme Area but wishes to invest in the Company or Dam, provided always that the transferee cannot hold more than 20% of the Water Shares on offer or issue at that time.

### **Sale or Subdivision of Property**

6.7 If the Water User owns property to which the Water Shares relate and elects to sell the property, or if the Water User leases property to which the Water Shares relate and elects to sublease the property then subject to clause 6.12 they may also transfer the Water Share (or appropriate parcel of the Water Share in the event of a subdivision) to the purchaser or sublessee of the property, but for the avoidance of doubt the Water Shares are not stapled to the land.

### **Board's right to refuse or delay registration of transfer**

6.12 The Board may, within 30 working days of the receipt of a form of transfer of Shares, refuse or delay the registration of the transfer if:

- (a) the transferee of the Share has not entered into the Company's then current Shareholder Water Augmentation Agreement;
- (b) the holder of the Shares has failed to pay an amount due to the Company in respect of those Shares (including any Water Charges);
- (c) the Board considers that to effect the transfer would result in a breach of the law;
- (d) the Board considers that it is not in the best interests of the Company to register the transfer;
- (e) the Board does not approve of the transferee, in respect of which matter the Board shall have absolute discretion in its decision;
- (f) clause 6.10 has not been complied with or the form of transfer has not been properly executed or does not comply with clauses 6.11;
- (g) the Board considers that any transfer would be in breach of any transfer moratorium put in place by the Board to meet any funder requirements, providing that such moratorium will not prohibit any transfers made in accordance with clause 6.1 (Transfer between Properties) or clause 6.7 (Sale or Subdivision of Property).
